

Competition Terms and Conditions

1. By participating in the N1 City Mall Spend & Win A Year's Supply Of Groceries Competition, participants agree to the terms and conditions set out below. The promoter reserves the right to disqualify a participant who does not comply with any of the terms and conditions of the competition.
2. The competition is open to everyone except the following people:
 - a) a director, member, partner, employee or agent of or consultant to the promoter or any other person who directly or indirectly controls or is controlled by the promoter as well as a supplier of goods or services in connection with the competition; or
 - b) a spouse, life partner, parent, child, brother, sister, business partner or associate of a person contemplated in paragraph (a).
3. Participants must be a South African citizen or permanent resident with a valid South African photo identification document and must be over the age of 18 years to qualify for entry.
4. This competition is run on behalf of N1 City Mall by advertising agency Word 4 Word Marketing Pty Ltd.
5. The Competition commences on 15 February 2019 at 09h00 and closes on 31 March 2019 at 17h00. No entries received after 31 March 2019 will be allowed.
6. The prize consists of five Checkers gift cards to a total value of R48, 000 (based on an allocation of R4, 000 per month over a 12-month period). Four Checkers gift cards will be loaded with R10, 000 and one Checkers gift card will be loaded with R8, 000.
7. The prize gift cards are valid for three years from the last date of activation and / or last top up.
8. A valid entry is an individual receipt from any store or restaurant in N1 City Mall, purchased between 15 February 2019 at 9h00 and 31 March 2019 at 17h00, to the value of R200 or more. Till slips cannot be accumulated to make up the value of R200. In the event that an original slip cannot be entered, a copy or re-print thereof may be used to enter this competition. Each slip may only be entered once.
9. To enter, customers must include their name and contact number on the back of their receipt. The receipt must then be placed in one of the four allocated entry boxes in centre.
10. The winner selection will take place on Monday 1 April 2019, by way of a random draw. The prize winner will be the first valid receipt drawn that includes the customer's name and contact number.
11. Should the organiser of the competition be unable to reach the winner within 12 hours after the random draw takes place the winner will forfeit their prize and another winner will be selected and announced.
12. The prize must be collected in person by the winner no later than 60 days after notification.

13. In order to collect the prize, the winner must present a valid South African photo identification document.
14. The prize is not transferable and is not exchangeable for cash. No substitution or assignment of the prize is permitted, but the organisers of the Competition reserve the right to substitute the prize with one of comparable value for any reason whatsoever.
15. The judges' decision is final and no correspondence will be entered into.

17. All risk and liability pertaining to any prize pass to the winner on signing over and receipt thereof.
